Notes:

- (1) Membership is annual and renewed effective October 1st of each year. All dues are applicable for the full year. Monthly dues include a 5% admin fee.
- (2) Unspent quarterly minimums are billed December 31, March 31, June 30 and September 30.
- (3) Must be enrolled full-time in a recognized post secondary education program, have a parent who is currently either a Principal, Associate or Sports Builder Member and must be a current Member. Student Members receive a 50% discount on Section Fees. Proof of full-time enrollment required.
- (4) A Principal Member or Associate Member who would otherwise be in the Senior Code 31 or Senior Code 21 membership category, who is 70 years of age or older, and who has been a Principal Member or Associate Member for 30 or more continuous years shall be in this category of membership.
- (5) See Rules and Regulations for Sports Builder criteria.
- (6) Must live and work at least 200km from the Club for minimum 6 continuous months annually and have been an Interm. or Senior Member previously. Annual Proof of Residency required.
- (7) Leave of Absence is granted for medical reasons only. Family Leave of Absence dues are \$750

Voting Members

A Voting Member is a Principal, Associate or Intermediate Member 19 years of age or older and has paid their entrance fees in full.
